GENERAL

We do collect your personal information and process your data in accordance with the IT Act, 2000 (21 of 2000) and other national and state laws which relate to the processing of personal data. HOW WE COLLECT THE INFORMATION

- i. From you directly and through this Site: We may collect information through the Website when you visit. The data we collect depends on the context of your interactions with our website.
- ii. Through business interaction: We may collect information through business interaction with you, your associates or your employees.
- iii. From other sources: We may receive information from other sources, such as surveys, public databases; references, joint marketing partners, social media platforms; or other third parties.
- iv. Updated delivery and address information from our carriers or other third parties, which we use to correct our records and deliver your next purchase or communication more easily.
- v. Information about your interactions with the products and services offered by our subsidiaries.

INFORMATION WE COLLECT

- i. We collect information primarily to provide better services to all of our customers.
- ii. We collect the following information from you when you use or signup on our Website:

- iv. We do collect the following personal sensitive information from you when you use or signup on our Website:
- v. The full Uniform Resource Locators (URL) clickstream to, through and from our website (including date and time); cookie number, products and/or content you viewed or searched for; page response times; download errors; length of visits to certain pages; page interaction information (such as scrolling, clicks, and mouse-overs).
- ix. We automatically collect information using "Cookies". Cookies are small data files stored on your hard drive the websites. Among other things, cookies help us improve our Site, our marketing activities, and your experience. We use cookies to see which areas and features are popular and to count visits to our Site.
- x. Most Web browsers are set to accept cookies by default. If you prefer, you can choose to set your browser to remove cookies and reject cookies. If you set your browser to reject cookies, some features will be unavailable. For more information on how to reject cookies, see your browser's instructions on changing your cookie settings.
- xi. By using this website, you are agreeing that we may advertise your feedback on the Website and marketing materials.

- xii. We will retain your information as long as we require this to provide you with the goods and services and for such a period as mandated by the concerned laws.
- xiii. If you opt to receive marketing correspondence from us, subscribe to our mailing list or newsletters, enter into any of our competitions or provide us with your details at networking events, we may use your data for our legitimate interests to provide you with details about our goods, services, business updates and events.

HOW WE USE INFORMATION

- i. We use the information we collect primarily to provide, maintain, protect and improve our current products and services.
- ii. We use the information collected through this website as described in this policy and we may use your information to
 - 1. Improve our services, Site and how we operate our businesses;
 - 2. Understand and enhance your experience using our Site, products and services;
 - 3. Personalize our products or services and make recommendations;
 - 4. Provide and deliver products and services you request;
 - 5. Process, manage, complete, and account for transactions;
 - 6. Provide customer support and respond to your requests, comments, and inquiries;
 - 7. Create and manage the online accounts you manage on our website;

HOW DO YOU GET YOUR CONSENT?

DATA TRANSFER

This includes exchanging information with other companies and organizations for fraud protection and credit risk reduction

COOKIES

- i. To optimize our web presence, we use cookies. These are small text files stored on your computer's main memory. These cookies are deleted after you close the browser. Other cookies remain on your computer (long-term cookies) and permit their recognition on your next visit. This allows us to improve your access to our site. This helps us to learn more about your interests, and provide you with essential features and services for additional purposes, including:
 - 1. Keeping track of items stored in your shopping basket.
 - 2. Conducting research and diagnostics to improve the content, products, and services.
 - 3. Preventing fraudulent activity.
 - 4. Improving security.
- ii. Our cookies allow you to take advantage of some of our essential features. For instance, if you block or otherwise reject our cookies, you will not be able to add items to your shopping basket, proceed to checkout, or use any products or services that require you to sign in.
- iii. Approved third parties also may set cookies when you interact with Our services.

DATA SECURITY

- i. We take due care to protect customer data. Technical measures are in place to prevent unauthorized or unlawful access to data and against accidental loss or destruction of, or damage to, data. The employees who are dealing with the data have been trained to protect the data from any illegal or unauthorized usage.
- ii. We work to protect the security of your information during transmission by using Secure Sockets Locker (SSL) software, which encrypts information you input. SSL allows sensitive information such as credit card numbers, UID's and login credentials to be transmitted securely.
- iii. We follow the Payment Card Industry Data Security Standard (PCI DSS) when handling branded credit cards from the major card schemes.
- iv. We maintain physical, electronic, and procedural safeguards in connection with the collection, storage, and disclosure of personal customer information.
- v. We take reasonable steps to help protect your personal information to prevent loss, misuse, unauthorized access, disclosure alteration and destruction. It is your responsibility to protect your user names and passwords to help prevent anyone from accessing or abusing your accounts and services. You should not use or reuse the same passwords you use with other accounts as your password for our services.
- vi. It is important for you to protect against unauthorized access to your password and your computers, devices, and applications. Be sure to sign off when you finish using a shared computer.
- vii. Information you provide to us is shared on our secure servers. PAYMENT

We use Razorpay for processing payments. We/Razorpay do not store your card data on their servers. The data is encrypted through the Payment Card Industry Data Security Standard (PCI-DSS) when processing payments. Your purchase transaction data is only used as long as is necessary to complete your purchase transaction. After that is complete, your purchase transaction information is not saved.

Our payment gateway adheres to the standards set by PCI-DSS as managed by the PCI Security Standards Council, which is a joint effort of brands like Visa, MasterCard, American Express and Discover.

PCI-DSS requirements help ensure the secure handling of credit card information by our store and its service providers.
